Please Do Your Own	Suggested	Description
133 - Protecting Partisan Primaries	Yes	Maintains current 1 person, 1 vote primaries by party. Each party nominates and puts forth their candidate or candidates aligning best with their values.
134 - Signature Distribution Requirement	Yes	Creates a signature distribution requirement for citizen-initiated ballot measures based on state legislative districts. Requires signatures from 10% of votes cast for governor in each legislative district to qualify initiated state statutes for the ballot and requires signatures from 15% of votes cast for governor in each legislative district to qualify initiated constitutional amendments for the ballot.
135 - Reining In Governors Emergency Powers	Yes	Provides for the legislature to terminate a state of emergency or alter the emergency powers of the governor during the state of emergency and provides for any emergency powers granted to the governor to automatically terminate 30 days after the state of emergency is proclaimed, unless the state legislature extends the emergency powers granted to the governor, and except in cases for a state of war emergency or an emergency arising from a flood or a fire.
136 - Pre-Election Initiative Challenges	Yes	Provides for challenges to an initiative measure or constitutional amendment after the filing of the measure with the secretary of state.
137 - Arizona Supreme Court Judge Term Limits	Yes	Ends term limits for state supreme court justices and superior court judges, replacing them with terms of good behavior, unless decided otherwise by a judicial review commission, and would end retention elections at the end of the judicial term, providing for retention elections under certain circumstances.
138 - Tipped Wage Protection	Yes	Allows for tipped workers to be paid 25% less per hour than the minimum wage if any tips received by the employee were not less than the minimum wage plus \$2 for all hours worked.
139 - Right to Abortion Initiative	NO	 Codifies the AZ Constitution imposing the following: Abortion on demand up to the point of fetal viability. In other words, when the baby can survive outside the womb. No parental notification, involvement, or approval is required which means minors can have an abortion without their parent's involvement. Tax-payers fund abortions if they are not covered under health insurance, or in the case of a minor that doesn't involve guardians / insurance coverage.

140 - Eliminate Partisan Primaries Amendment	NO	Eliminates partisan primaries and replaces them with an electoral system where individuals may vote for the candidate of their choice, regardless of the party affiliation of the voter or the candidate. Allows the Secretary of state to choose which and how many candidates are selected to run in the general election if the legislature does not act in a timely fashion.
212 - \$18 Minimum Wage Initiative	Removed	Increases the minimum wage to \$18 per hour and continues to increase the minimum wage based on inflationas measured by the consumer price index. The measure would also gradually raise the wage of tippedemployees to be equal to the wage of other employees by 2028.
311 - First Responder Survivor Benefits	YES	Establishes a \$20 fee (it could change in the future) on every conviction for a criminal offense, which would go to pay a benefit of \$250,000 to the family of a first responder who is killed in the line of duty.
312 - Protecting Property Owners	YES	Allows for property owners to apply for a property tax refund in certain circumstances, including in instances if the city or locality in which the property is located does not enforce laws regarding illegal camping, loitering, obstructing public thoroughfares, panhandling, public urination or defecation, public consumption of alcoholic beverages, and possession or use of illegal substances.
313 - Life Imprisonment for Sex Trafficking	YES	Provides for life imprisonment for an individual who is convicted of class 2 felony sex trafficking of a child.
314 - Arizona Immigration and Border Law Enforcement	YES	Allows for state and local police to arrest noncitizens who cross the border unlawfully, allows for state judges to order deportations, requires the use of the e-verify program for some public governmental programs and employment eligibility purposes, and makes the sale of fentanyl a Class 2 felony if a person knowingly sells fentanyl resulting in the death of another person.
315 - Arizona Legislative Ratification of State Agency Rules	YES	The measure would require that any proposed rule projected to increase regulatory costs in the state by over \$500,000 within five years of implementation to be submitted to the Office of Economic Opportunity for review. The legislature, or any person who is regulated by an agency proposing a rule, may also request proposed rules to be sent to the Office of Economic Opportunity for review.
479 – 20 Year Sales Tax Extension for Transportation	NO	A continuation of an existing, dedicated half-cent sales tax in Maricopa County to fund transportation. This initiative extends the sales tax for 20 years. The breakdown of spending is: 40.5 percent of the sales tax will be allocated to freeways and highways, 22.5 percent to arterial roads and regional transportation infrastructure, and 37 percent to transit. Increases light rail, installs streetcars and bus rapid transit; reduces driving lanes.
